

PRIVACY POLICY

- 1. Introduction.** We at Over65LowIncomeInsurance (“We,” “Us” or “Over65LowIncomeInsurance”) respect your privacy and are dedicated to protecting your personal information through our compliance procedures entailed in this Privacy Policy (“Policy”). Please study the following information carefully as it details the type of information we may collect from you or that you may provide to us when you visit Over65LowIncomeInsurance (“Website”), and our practices for collecting, using, maintaining, protecting, and disclosing such information. Personally Identifiable Information. Non-Personally Identifiable Information. We also collect information automatically as you navigate through this Website. We use log files and cookies to collect Non-Personally Identifiable Information (“Non-PII”) including, but not limited to, the IP address of the computer or mobile device making the request, browser type and the times you access this Website and usage details. Please note that IP addresses are not usually associated with your personal computer, but with a portal through which you accessed the Internet. Cookies.
